ARTS & CRAFTS OR MERCHANDISE VENDOR RULES & REGULATIONS

Each Vendor must be set up and ready on Friday evening by 5:00 p.m.

Gates Open at 6:00 p.m.

Booths must remain open until the dance starts.

Vendors are welcome to stay open later at their discretion.

Saturday Gates Open at 8:00 a.m.

Vendors must be completely setup by 10:00 a.m.

Booths must remain open until the dance starts.

Vendors are welcome to stay open later at their discretion.

Space size will be 10' X 10'

- All Vendors are required to bring their own canopy and display tables.
Any vendor selling merchandise will pay a commercial flat fee of \$250.00 per booth. .
- Our insurance company requires all vendors to provide their own General Liability
- Our insurance company requires all vendors to provide their own General Liability Coverage including Products and Completed Operations per Occurrence \$1,000.
Certificate of Insurance must name the Pleasanton Chamber of Commerce and Cowboy Homecoming as additional insured's.
- All vehicles must be off festival area and in designated parking area by set up time on Friday. Unload, move your vehicle, then arrange your booth!
- Vendor is responsible for submitting ALL applicable taxes to the proper agencies. Please contact your nearest Texas State Comptroller's Office or call (800)262-5555.
- Vendor will receive 1 parking pass only. NO EXCEPTIONS, so do not inquire! Wristbands may be purchased.
- Vendors must submit photos of items to be sold with application.
- Booths will be assigned on a *first-come, first-served basis or by your items*.
